Mean (SD) t(1/2) of R-furosemide was longer than that of S-furosemide, 14.6 (5.8) versus 6.1 (1.7) hours, in the patients with cirrhosis, and 18.0 (8.5) versus 6.7 (0.9) hours in the controls, respectively. There was also a marked difference in the AUC(0-infinity) between S-furosemide and R-furosemide in the patients with cirrhosis, 26.1 (16.3) versus 16.5 (4.6) mg.h/l, whereas it was slightly but significantly lower in the controls, 19.4 (13.2) versus 22.0 (8.1) mg.h/l. The difference between the furosemide enantiomer AUC(0-infinity) values in the patients with cirrhosis and the control patients indicate that enantioselective elimination of S-furosemide was increased in patients with cirrhosis, whereas enantioselective absorption of R-furosemide was decreased.
