

(c) A certificate of amendment shall set forth: (1) The name of the corporation and, in the case of a foreign corporation, the state under the laws of which it is incorporated; (2) the address of the corporation's principal office; (3) the corporation's business address; and (4) the address of the registered agent at that office, if any. The certificate shall specify the effect of the amendment on the principal purpose of the corporation or on its compliance with the law of this state. For the purposes of this subsection, a showing of good cause shall include, but not be limited to, a showing that public disclosure of the residence addresses of the corporation's directors and officers may expose the personal security of such directors and officers to significant risk. Sec. 33-1214. Amendment of certificate of authority to conduct affairs in this state. (a) A corporation may amend its certificate of authority to conduct affairs in this state by delivering a certificate of amendment to the Secretary of the State for filing. The certificate shall set forth: (1) The name and business address of the corporation; (2) the name of the state or foreign country under whose laws it is incorporated; (3) the street address of the principal office of the corporation; (4) the address of its registered agent at that office, if any; (5) the address of its executive offices, if any; (6) the name and respective business and residence addresses of the directors and officers of the corporation, except that if good cause is shown, the Secretary of the State may accept business addresses in lieu of business and residence addresses of the directors and officers of the corporation; and (7) such additional information, including the North American Industry Classification System Code, that the Secretary deems pertinent for determining the effect of the amendment on the principal purpose of the corporation or on its compliance with the law of this state. For the purposes of this section, a showing of good cause shall include, but not be limited to, a showing that public disclosure of the residence addresses of the corporation's directors and officers may expose the personal security of such directors and officers to significant risk.

When filing a license renewal with the Office of Motor Vehicle, make sure to have documentation with you. The license renewal is the number of days that the vehicle has been in the state. As long as the vehicle has been in the state during that time frame, the fee is lower. For example, if the vehicle has been in the state for 180 days, that is the amount of time the vehicle will be eligible for the lower rate. If the vehicle has been in the state for 200 days, that is the amount of time the vehicle will be eligible for the lower rate. For other time frames, it may be necessary to have a physical receipt. Sec. 33-1213.

Application for amendment of certificate of authority to conduct affairs in this state. (a) A foreign corporation may apply for an amendment to its certificate of authority to conduct affairs in this state by delivering an application to the Secretary of the State for filing. The application shall set forth: (1) The name and business address of the applicant; (2) the name and business address of the applicant's registered agent at the principal office of the applicant in this state, if any; (3) the nature of the amendment; (4) a statement that the board of directors has adopted a resolution authorizing the corporate acts contemplated in the amendment; (5) a statement that the applicant has filed such application and that the applicant's agent designated in the application for filing has authorized the filing in this state; and (6) any other information concerning the application that the Secretary deems pertinent for determining the effect of the amendment on the principal purpose of the corporation or on its compliance with the law of this state. 5ec8ef588b
